Dear Glenn Simon,

Field Environmental Consulting, Inc. (FIELD ENVIRONMENTAL) appreciates the opportunity to provide results for lead in drinking water sampling conducted at Hidden Valley Elementary.

Initial sampling ("first draw") was completed on Friday, October 26, 2018⁺. Two (2) out of the seventy-two (72) initial first draw samples collected at Hidden Valley Elementary School were above the recommended limit of 20 ppb. Provided with results, ISD #191 cleaned aerators for the identified taps. After aerator cleaning was completed, ISD #191 re-sampled identified taps on November 29, 2018. Re-sampling results were below the recommended limit of 20 ppb.

Analysis was conducted by Pace Analytical Services, Inc. of Minneapolis, Minnesota using EPA Method 200.8 ICPMS for determination of trace elements in drinking water.




